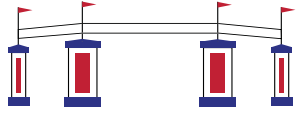

## DEMOLITION DERBY OFFICIAL RULES AND REGULATIONS

### PARTICIPATION REGULATIONS

1. Drivers must be 16 years or older
2. Drivers may maneuver forward or backward.
3. **No one under the age of 14 will be allowed in the pits for "safety & insurance".**
4. NO DELIBERATE HEAD-ONS OR HITTING OPPONENT'S CAR IN DRIVER'S DOOR. **AUTOMATIC DISQUALIFICATION.**
5. NO SANDBAGGING, JUDGES DISCRETION. A ONE MINUTE TIME LIMIT IN EFFECT.
6. GREEN flag means GO . . . RED flag means STOP . . . BLACK flag means **YOU ARE DISQUALIFIED, STOP YOUR CAR.**
7. All drivers **MUST** attend the pit meeting as scheduled.
8. NO TEAM DRIVING.
9. THE DECISION OF THE JUDGES IS FINAL.

### SAFETY AND CAR INSPECTIONS

1. Cars ONLY. No trucks, jeeps, convertibles, etc.
2. ALL drivers must wear a safety helmet and eye protection.
3. Seat belts **MUST** be worn. They must be securely fastened to the frame.
4. All glass **MUST** be removed including headlights and tail lights.
5. The rear seat **MUST** be removed.
6. No special bumpers, extra weights, trailer hitches, special lifts, air lifts, tire chains, etc. All trunks must be empty of debris, spare parts, tires, etc.
7. Radiators and fans may be removed but **NOT** relocated. Batteries must be relocated to a secure area.
8. Roll-over bars are allowed but not necessary.

9. Bumpers and fenders may be trimmed.
10. Driver's door **MUST** be reinforced. Up to 3" tubing may be installed directly behind front seat from side to side for driver protection. **ALL OTHER REINFORCING, WELDING OR BOLTING IS PROHIBITED OTHER THAN DRIVER'S DOOR.**
11. A maximum of 3 gallons of gas will be allowed. This **MUST** be in a separate tank **RELOCATED AND SECURED** in the rear seat area. Original gas tank must be removed.
12. All loose chrome mouldings should be removed.
13. Slogans, advertising or printing may be placed anywhere **EXCEPT** the front doors. The drivers **name and number MUST** be on both front doors. You may choose your own number.
14. Yxou will have a flag taped to your car before you enter the heat. When your car is no longer able to run, the flag stick will be broken to show the others that you are no longer in competition. Cars with the FLAG UP CAN BE HIT.
15. Stay in your car during the heats and keep your seat belt **FASTENED.**
16. **ABSOLUTELY NO ALCOHOLIC BEVERAGES OR CONTROLLED SUBSTANCES WILL BE PERMITTED IN THE PIT AREA BY THE DEMOLITION DRIVER AND/OR PIT MEN.** ANY DEMOLITION PERSONNEL (DRIVERS OR PIT CREW MEMBERS) OBSERVED USING OR UNDER THE INFLUENCE OF ALCOHOL OR A CONTROLLED SUBSTANCE WILL BE IMMEDIATELY DISQUALIFIED AND BARRED FROM THE AREA WITH THE FORFEIT OF ALL MONEY EARNED. VIOLATIONS MAY BE ISSUED BY LAW ENFORCEMENT.
17. Access to engine compartment for fire suppression should be provided, 18 inches minimum.
18. No fluorescent or red paint on rims or tires.
19. Remove or disable air bags
